



## NuStar Energy L.P. Declares Third Quarter 2023 Common Unit Distribution and Series A, Series B and Series C Preferred Units Distributions

SAN ANTONIO--(BUSINESS WIRE)--Oct. 25, 2023-- NuStar Energy L.P. (NYSE: NS) today announced that its Board of Directors has declared a third quarter 2023 common unit distribution of \$0.40 per unit. The third quarter common unit distribution will be paid on November 14, 2023 to holders of record as of November 7, 2023.

NuStar Energy L.P.'s Board of Directors also declared a third quarter 2023 Series A preferred unit distribution of \$0.77736 per unit, a Series B preferred unit distribution of \$0.70717 per unit and a Series C preferred unit distribution of \$0.78448 per unit. The preferred unit distributions will be paid on December 15, 2023 to holders of record as of December 1, 2023.

The partnership's combined system has approximately 49 million barrels of storage capacity, and NuStar has operations in the United States and Mexico.
